What is this product?

Type

This product is a UCITS.

The fund has no termination date. However the Management Company may, at its discretion, decide to terminate or merge the fund or its unit series.

Objectives

Storebrand Equal Opportunities is a fossil-free equity fund that seeks to invest in international companies that are helping to achieve the Sustainable Development Goals (SDGs) by enabling more people to access essential services that improve quality of life.

The fund is actively managed and provides exposure to companies helping to equalise disparities in society by providing better access to financial services, digital services and health services. These include companies that focus on, for example, women's health, microfinance, internet access and digital health.

The fund invests in many different sectors and throughout the entire value chain of identified solutions. The companies are characterised by high expectations concerning future performance and thus high risk in relation to price changes, and the fund will therefore involve greater risk for assets than broader global funds. The fund's returns may deviate considerably from the benchmark index due to the fund's investments primarily focusing on a limited part of the benchmark index's investment universe.

The fund does not invest in companies that breach international standards and conventions. These include human rights, labour and international law, corruption and financial crime, serious climate and environmental harm and controversial weapons (landmines,

cluster munitions and nuclear weapons). The fund also excludes companies that derive more than 5 per cent of their earnings from the production and/or distribution of tobacco, weapons, alcohol, gambling, pornography, cannabis and fossil fuels, as well as companies with large fossil reserves.

Dividends and other income received by the fund are reinvested and included in the unit value.

Benchmark: MSCI All Country World Indeks Net.

Intended retail investor

The fund offers a diversified portfolio of securities for investors interested in wealth accumulation, pension savings or similar investment purposes.

The recommended holding period of the fund is at least 5 years assuming the fund is the sole or major holding of the investor. The recommended holding period is primarily based on the historical volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.

The fund is intended for investors who accept and understand that the value of the fund is directly linked to the value of underlying investments, will fluctuate over time and that the invested amount can be lost entirely or partly. Investments in the fund require no specific knowledge of the financial market or instruments from the investor.



What are the risks and what could I get in return?

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.





This risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium-high level. Other risks materially relevant to the PRIIP not included in the summary risk indicator: Event risk, liquidity risk, operational risk, counterparty risk, derivatives risk.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if Storebrand Asset Management AS is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of our insolvency, the Fund's assets in the safekeeping of the depositary will not be affected. However, in the event of the insolvency of the depositary, or someone acting on its behalf, the Fund may suffer a financial loss. This loss will not be covered by any investor compensation or a guarantee scheme. However, this risk is mitigated to a certain extent by the fact that the depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure to properly fulfil its obligations (subject to certain limitations).

What are the costs?

Costs over time

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- NOK 100 000 is invested.
