## What is this product?

### Type

This product is a UCITS.

The fund has no termination date. However the Management Company may, at its discretion, decide to terminate or merge the fund or its unit series.

### Objectives

Storebrand Global Indeks is an index equity fund that aims to achieve the same increase in value as the global stock market.

The investments in the underlying shares reflect the composition of the benchmark index in so far as possible. Storebrand's sustainable investment standard forms the basis for the fund's management, and, for example, the fund refrains from investing in companies that violate international laws and regulations, human rights or workers' rights, are involved in corruption, serious climate or environmental damage, controversial weapons (land mines, cluster and nuclear weapons) or tobacco or that score low on sustainability. The expected relative volatility is to be as low as possible and limited to a maximum of 1.5 per cent.

Dividends and other income will be reinvested in the fund.

Derivatives may be used to ensure less expensive or more efficient management.

Benchmark: MSCI World Net.

### Intended retail investor

The fund offers a diversified portfolio of securities for investors interested in wealth accumulation, pension savings or similar investment purposes.

The recommended holding period of the fund is at least 5 years assuming the fund is the sole or major holding of the investor. The recommended holding period is primarily based on the historical volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.

The fund is intended for investors who accept and understand that the value of the fund is directly linked to the value of underlying investments, will fluctuate over time and that the invested amount can be lost entirely or partly. Investments in the fund require no specific knowledge of the financial market or instruments from the investor.

The Fund's Depositary is J.P Morgan SE - Oslo Branch.

## What are the risks and what could I get in return?

### Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level. ## What happens if Storebrand Asset Management AS is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of our insolvency, the Fund's assets in the safekeeping of the depositary will not be affected. However, in the event of the insolvency of the depositary, or someone acting on its behalf, the Fund may suffer a financial loss. This loss will not be covered by any investor compensation or a guarantee scheme. However, this risk is mitigated to a certain extent by the fact that the depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure to properly fulfil its obligations (subject to certain limitations).

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
