What is this product?

Type

This product is a UCITS.

The fund has no termination date. However the Management Company may, at its discretion, decide to terminate or merge the fund or its unit series.

Objectives

Storebrand Global Multifactor is an equity fund that aims to achieve a long-term excess return by investing in global, well-developed stock markets. The fund is actively managed and investment choices are made using a self-developed model-based methodology. The fund seeks to utilize well-documented risk premiums linked to the factors; value, size, momentum and low volatility. The portfolio is sector and region neutral, balanced at factor level, and normally contains 300-400 large and medium-sized companies from the benchmark index.

Dividends and other income will be reinvested in the fund.

Derivatives can be used for less expensive or more efficient management.

Benchmark: MSCI World net return.

Intended retail investor

The fund offers a diversified portfolio of securities for investors interested in wealth accumulation, pension savings or similar investment purposes.

The recommended holding period of the fund is at least 5 years assuming the fund is the sole or major holding of the investor. The recommended holding period is primarily based on the historical volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.

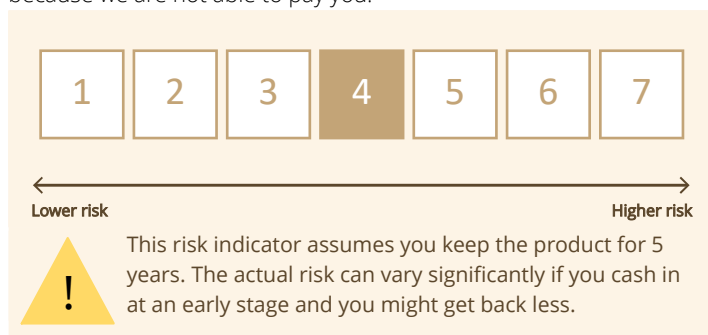
The fund is intended for investors who accept and understand that the value of the fund is directly linked to the value of underlying investments, will fluctuate over time and that the invested amount can be lost entirely or partly. What are the risks and what could I get in return?

Risk Indicator

What happens if Storebrand Asset Management AS is unable to pay out?

This loss will not be covered by any investor compensation or a guarantee scheme. However, this risk is mitigated to a certain extent by the fact that the depositary is required by law and regulation to segregate its own assets from the assets of the Fund. What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. - In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
